Leaders in Law Awards Reflect Well on Legal Community

RECOGNITION: Judges Narrowed 105 Finalists To 17 Winners

San Diego's legal community converged at **The University Club Atop Symphony Towers** on Oct. 24 to honor the region's brightest legal minds. The occasion was the **San Diego Business Journal's** inaugural Leaders in Law Awards.

One of the best views seemed to be from the lectern. **Chris Olmsted** — a shareholder at event sponsor **Ogletree Deakins** and the first person to present an award that evening — said he saw something in the crowd of 200.

"Looking out, it crossed my mind what a great pool of legal talent we have here in San Diego," he said after the event. "We have the foremost experts in the world. ... It was good to see all the people in the same room."

Seventeen people accepted awards. Most awards honored the top attorney in a particular specialty. Three in-house general counsel attorneys were honored, as were three Rising Stars — attorneys early in their careers who we will likely hear more from.

A Challenge for the Judges

Five business leaders served as judges

for the event. **Rana Sampson** was one of them, poring over 105 finalist applications, tallying points to determine who would go home with winners' plaques. She said she used a matrix to help in the process.

"I was so thrilled to see the level of competition," said Sampson, director and community relations ambassador for **MUFG Union Bank's** Southern California and San Diego divisions. "It speaks well for San Diego's legal profession and potential clients."

Dr. **David Crean**, Ph.D., was another judge. It was one thing to rank the nominees on professional abilities and accomplishments, Crean said before the event began. But that is not everything. "How are they giving back?" asked Crean, who is managing director for health care and life sciences with **Objective Capital Partners**.

Meaningful community involvement carried significant weight with Crean, Sampson and **Tracie Childs**, co-chair of **Ogletree Deakins**.

Chris Bryant, CEO of the **San Diego Employers Association**, also spent time with the finalist applications (narrowed from more than 200 nominations). The

finalists' track records made the contest "a tough one to judge," she said. Bryant said she was impressed by the finalists' professional accomplishments, such as significant case wins and sizable settlements. Many nominees invested time in their firms and in mentoring new associates, which reflected well on them, she said.

"It's hard not to rank everybody right at the very top," said **Peter Callstrom**, another judge for the event. Callstrom is CEO of the **San Diego Workforce Partnership**.

Southwest Airlines, **Union Bank** and **Green Rope** joined **Ogletree Deakins** as sponsors for the event.

Looking Back, and Ahead

There was a chance for winners to say a few words as part of the ceremony. **Paul Najar**, general counsel for **Gafcon**, compared winning the award to the feeling of making a great softball play when he was 10 years old. Najar is also president of the San Diego chapter of the **American Corporate Counsel Association**.

Another winner — **Jennifer Chang**, junior partner at **Hecht Solberg Robinson Goldberg & Bagley LLP** — said being

part of the awards ceremony was a motivating experience.

"Hearing the accomplishments of the other winners inspired me to continue to hone my craft and to devote more time and energy to serving this great community," said Chang, who won in the Real Estate category.

Crowded Calendars

The evening received great reviews from others in the legal community.

"The event really distinguished itself by being held in such a beautiful venue, with great food and a great bar," said **Bill Eigner**, partner with **Procopio**. "It was fun being with friends and colleagues."

"I was very impressed. The event was well attended. The awards, and awards process, appeared to be well regarded and appreciated," said **Ron Marcus**, director of marketing and outreach for the **San Diego County Bar Association**.

"Attorneys are busy people with busy lives," Marcus continued. "It was nice to see so many attorneys able to attend this event to support their colleagues and peers as they received recognition for their achievements and contributions to the community." ■

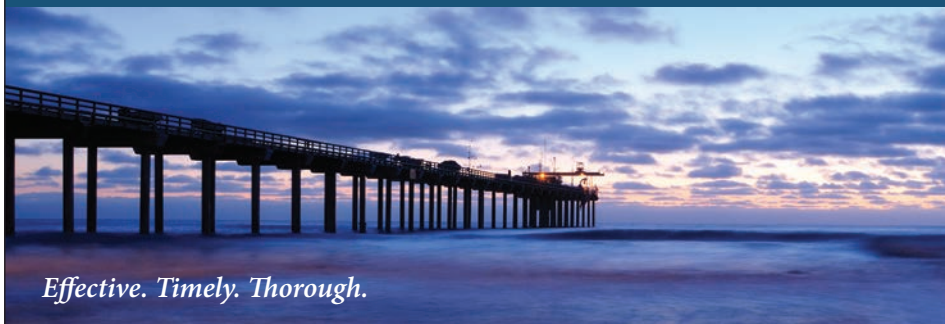
