Luke Bergmann, Ph.D., is Director of Behavioral Health Services for the County of San Diego, Health and Human Services Agency. He has worked for the county since 2018. Since then he has established a strategic vision for behavioral health reform in the region. He has transformed care and doubled the size of the county's Behavioral Health Services. He also established the Crisis Diversion sector in the county, including establishing regionally distributed crisis stabilization units (CSUs) and new mobile crisis response teams (MCRTs).

Dr. Bergmann previously worked for nine years in New York City, most recently as Assistant Vice President over Behavioral Health at NYC Health + Hospitals, the nation's largest public hospital system and before that, as Director of the Office of Program and Policy in the Bureau of Alcohol and Drugs at the NYC Department of Health. He has held a variety of academic research and faculty positions, including at Oregon Health and Science University, the University of Michigan and the City University of New York. Dr. Bergmann earned a Ph.D. in Social Work and Cultural Anthropology from the University of Michigan. He completed post-doctoral fellowships at UC San Francisco's Institute for Health Policy and UC Berkeley's School of Public Health.

Dr. Hilary Bowers is the founding Director of Behavioral and Mental Health Services at Children's Primary Care Medical Group (CPCMG). She spearheads the CPCMG Mental Health Initiative to create Centers of Excellence to improve delivery of behavioral and mental health care to children and adolescents. CPCMG provides health care across San Diego and Riverside counties serving needs of 280,000 children.

Dr. Bowers graduated magna cum laude from the University of Pennsylvania and received her medical degree from the University of Washington where she researched the efficacy of telemedicine for rural populations. She completed her internship and residency at Cedars-Sinai Medical Center in Los Angeles with additional training at Boston Medical Center, Division of Developmental and Behavioral Pediatrics and is a Board Certified Pediatrician.

Dr. Bowers has served on CPCMG's Board of Directors, Pharmacy and Therapeutics Committee, Telemedicine Taskforce among others. Outside of CPCMG, she has been a member of the Rady Children's Hospital San Diego (RCHSD) Pediatric Mental Health Integration Committee and the Epic Optimization Build Team. She has also been active with Children's Physicians Medical Group's Quality of Care Committee. Currently, she is Lead Pediatrician of the Primary Care Mental Health Integration program as part of the Transforming Mental Health Initiative at RCHSD.

Byzak has served in positions of progressive leadership in Emergency Medical Services, health policy, healthcare management and consulting for more than two decades. He joined Tri-City in 2018 and is responsible for the medical center and healthcare district's marketing, communications, government affairs, community engagement and patient transportation.

Moises Estrada is Director of Clinical Operations for Residential Treatment Centers with Lightfully Behavioral Health. Dr. Piedad Garcia is the Deputy Director for San Diego County Behavioral Health Services (BHS) overseeing the Adult and Older Adult System of Care. Over her career, Dr. Garcia has implemented an array of behavioral health services for individuals with serious mental illness and/or substance use conditions, including leading efforts to integrate services and the development and implementation system of care initiatives. She currently oversees County-operated case management and outpatient services, which provide direct services to adults of all ages. Dr. Garcia also oversees a portfolio of contracted substance use and mental health services of over 150 contracts with budgets totaling nearly \$400 million annually, which includes Assertive Community Treatment services, treatment services for adults who are experiencing homelessness and/or justice involvement, biopsychosocial rehabilitation services, substance use disorder residential services and opioid treatment programs. She has also been pivotal in implementing new services such as the first Community Harm Reduction team in the Central Region of San Diego County, regional crisis stabilization units in Vista and Oceanside and the countywide Mobile Crisis Response teams. She is also recognized as a behavioral health expert across the community, often being interviewed by the media on behalf of the department.
