Points of Light Board Chair **Neil Bush**, one of the former president's sons, gave the keynote address.

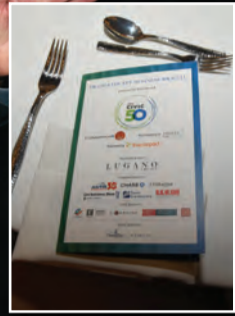
