Consulting Firms Report 18% Increase in OC

Deloitte Regains No. 1; Slalom Makes Big Debut

Orange County's largest management consulting firms are reporting a return to hiring this year.

The 23 largest firms on the Business Journal's annual list reported a 18% increase to 2,103 consultants and a 10% rise in Orange County employees to 5,028.

A year ago, they reported a 3.7% decline in consultants and a 4.7% drop in OC employees.

Management consultant firms provide an array of specialists in information technology, operations, strategy, and mergers and acquisitions aimed at improving the performance of businesses.

This week's list, which ranks firms with a minimum cutoff of 10 area consultants, includes management consulting firms with headquarters in Orange County and others with operations here.

Companywide, firms on the list grew 13% to 2 million employees, compared to a 6.3% growth last year.

Irvine is clearly the city to be a consultant as 15 reported its offices here, followed by Costa Mesa with three and Newport Beach with two.

Thirteen of the firms reported gains, including 11 that grew by more than 10%. On last year's list, only seven of the firms reported an increase in consultants.

Only two reported declines, compared to

five a year ago. Eight didn't report any changes.

Deloitte LLP, which has an office in Costa Mesa, regained its top slot by boosting headcount 30% to 361 and its OC employee count 15% to 978. Last year, its OC consultant count fell 10%.

Accenture, which has an Irvine office, fell to No. 2 even though it increased its consultants 18% to 347 and its OC headcount by

15% to 390. A year ago, it reduced its consulting headcount by 13%.

"The most profound change we are seeing in business is the demand for total enterprise transformation, which goes beyond a specific industry, business unit or function," said Marty Hodgett, Accenture's office managing director for Southern California. "Many organizations are

driving bold transformation programs in accelerated time frames as they recognize the need to engage every part of their enterprise and their people using technology, data and AI to work in new ways."

Consulting Blur

The advances in tech and greater access to data are even further blurring the lines between consulting and accounting, according to **Vivek Mande**, director of the school of accountancy at **California State University**, **Fullerton**.

"Clients want to make business decisions on things like margins for products and sales," Mande told the Business Journal.

> "They could get consultants or outside people, but accountants have a unique advantage because they are the custodians of their clients' data.

> "That's why the consulting arm of accounting firms is starting to grow. Clients now not only want advice on the traditional accounting fields like taxation and audit-

ing, but also advice on various business decisions that are data-driven," he said (see related story, page 22).

For the second straight year, Irvine-based No. 7 **Blythe Global Advisors LLC** reported

a significant growth of 30% to 103 employees, which follows a 76% gain on last year's list.

"Our flexible work environment coupled with our seasoned experienced team of former Big Four trained CPA professionals has led directly to our tremendous growth the past year," President **Marc Blythe** said in an email to the Business Journal.

"We expect to continue to ensure the demand of our services due to the prolific shortage of accounting talent within public accounting and industry combined with the recent IPO/SPAC activity."

Notable Changes

- Making its appearance on this year's list is **Slalom LLC**, which said the employment count at its Irvine office jumped 61% to 135, good for the No. 5 spot. The Seattle-based company says it can "push the boundaries of what's possible" to help clients "explore the next frontier of technology and customer experiences."
- Another company making an appearance on this year's list is No. 21 Chicagobased **Crowe LLP**, which said its Costa Mesa office climbed by four to 11 consultants
- Another fast grower from Chicago was **RSM US LLP**, which rose 55% to 76 at its Irvine office.
- No. 10 **Tevora** of Irvine said its head-count fell by four to 83 consultants. The company grew elsewhere as its employee count increased 14% to 183 company-wide. ■

The Butterfly vehicles are being designed to have a range of over 100 miles, the ability to recharge quickly between trips, and a top speed of around 200 miles per hour.

"We've proven Butterfly's propulsion system, so we'll now begin validating Butterfly's ability to operate safely in real-world weather conditions, carry significant payloads, and fly incredibly quietly," Tigner said in a statement on June 14.

The slow turning propellors used by Overair produce extraordinarily little sound, which will allow Butterfly to operate in high-density areas with noise sensitive communities, the company said.

As the company continues to work toward FAA certification, Overair is also working with **NASA** and **Urban Movement Labs** in Los Angeles to develop urban air mobility routing and infrastructure.

While Overair has been testing its electric motor systems in the Southern California desert, it operates out of 203,000 square feet of space in two buildings at 3001 S. Susan St. and 3030 S. Susan St., near **Segerstrom High School**.

Supernal Neighbor

Along with Overair and Joby Aviation, other companies charging into the flying taxi sphere include **Supernal**, a new division of South Korea's **Hyundai Motor Group**. Supernal's headquarters are in Washington, D.C., but its engineering base and largest source of jobs was established in Irvine last year.

Other competitors include European plane maker **Airbus** and Germany's **Volocopter**.

The skies won't be too crowded with



eVTOL competition, Tigner told the Business Journal earlier this year.

"There's a group of companies that are all in a competition with each other of sorts, although I will say at least in the short term it's far more collaborative than competitive," Tigner said of the industry.

He adds: "The potential market is much, much larger than any one company can fill."

The development of the eVTOL industry has faced numerous challenges, chief among them the safety of the people on the ground and those in the air.

"We are working very closely with the FAA to see how these kinds of aircraft are going to be certified," Tigner said. "We don't fit cleanly into the mold of a regular airplane or a regular helicopter or any other known category."

Korean Heavyweights Back Overair

Hanwha Aerospace and **Hanwha Systems** are the two South Korean firms backing flying taxi company **Overair** of Santa Ana.

Overair calls them "global leaders in ultra-precision communications and aircraft technologies." Hanwha Aerospace is the only large aircraft engine manufacturer in South Korea. It's also involved in outer-space, including its 2021 buy of **Satrec Initiative**, a domestic satellite specialist.

Hanwha Systems provides "differentiated smart technologies" in defense electronics and other high-tech fields.

The South Korean firms say they are looking to invest in disruptive businesses that can "really excel in the future," and believe Overair's eVTOL vehicle is one of those game changers.

"With regard to our investment decision in Overair, we assessed that the company had the numerous patents and core technologies required to develop [a] highly efficient, low noise vehicle," **Sungchul Eoh**, CEO of Hanwha Systems, said in a statement.

"We see the potential of Overair's Optimum Speed Propulsion system and we will continue to work together to find synergies and bring this breakthrough technology to the world," he said.
