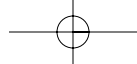

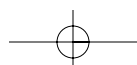

Diann's Defenders

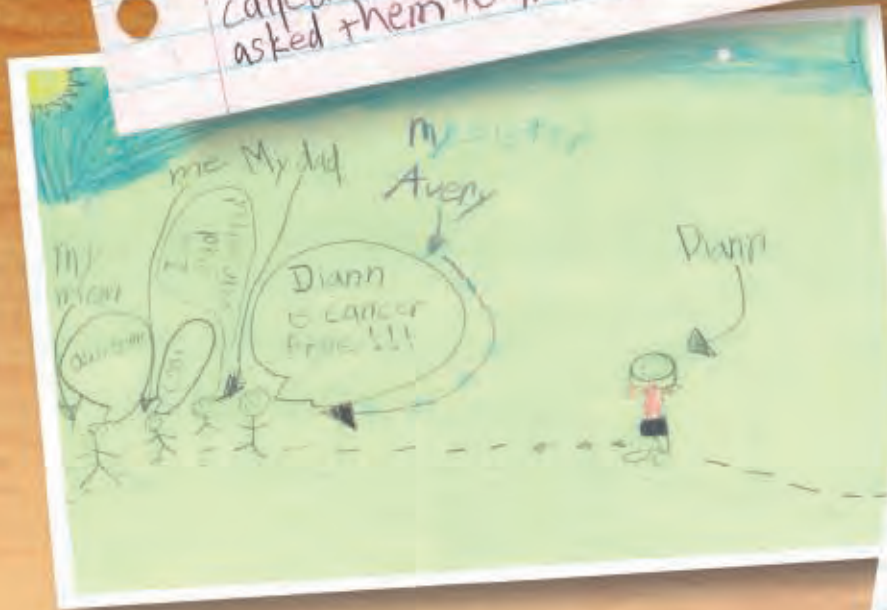

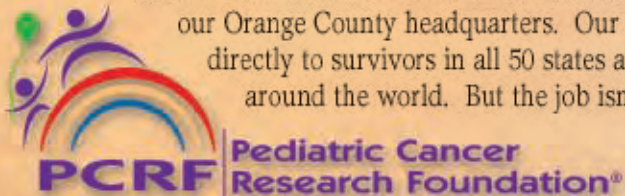

Susan's Story

Our tragedy struck in June 2008 when I was laid off from my job of 12 years due to budget cuts. I'm a single mother who earned enough to own my own home and support myself and my son Kyle. I searched exhaustively for work but was unable to find a job and eventually, my home went into foreclosure. I had no family to turn to. Kyle and I lived in my car for a few days - then I was referred to an Orange County United Way funded nonprofit.



Kyle and I received food, weekly counseling and help with child care. A career coach also helped me focus my efforts on finding a job and rebuilding my life. Now I work full-time as an administrative assistant and am in my final semester for an interpretation degree and I can afford an apartment for Kyle and I.

I went from feeling completely hopeless to taking control of my family's future. I'm so thankful for the help I received to get to this place of stability.
